

Terms of Service

Membership terms for Trifecta HQ products and services offered through Whop.

1. Acceptance of these Terms

These Terms of Service govern your purchase of and access to the Trifecta HQ membership, community, educational content, indicators, and related services offered through Whop. By purchasing, accessing, or using the membership, you agree to these Terms, the applicable Return Policy, the Privacy Policy, the End User License Agreement, and Whop's own terms and policies.

If you do not agree, do not purchase or use the membership.

2. Eligibility

You must be at least 18 years old and legally able to enter into a binding contract. You are responsible for ensuring that your purchase and use of the membership are lawful in your jurisdiction.

3. Membership Services

Trifecta HQ provides a combined digital membership that may include a private Discord community, daily and weekly market outlooks, educational lectures, live market commentary, assignments, feedback, community support, live execution reviews, and access to invite-only TradingView indicators.

The exact content, schedule, format, features, instructors, platforms, and availability may change over time. Unless expressly stated otherwise, membership does not include private investment management, individualized financial planning, brokerage services, or guaranteed access to any specific person at a specific time.

4. Educational Purpose Only

All content is provided solely for general educational and informational purposes. Trifecta HQ does not provide financial, investment, legal, tax, brokerage, or trading advice. Nothing provided through the membership is a recommendation, signal, solicitation, or instruction to buy, sell, or hold any asset.

You are solely responsible for your own research, decisions, orders, risk controls, and results. No fiduciary, adviser-client, broker-client, or similar professional relationship is created.

5. Trading Risk

Trading and investing involve substantial risk and can result in the loss of some or all capital. Leveraged products, futures, options, foreign exchange, digital assets, and funded or proprietary trading accounts may involve additional risks and restrictions. Past performance, examples, backtests, hypothetical results, and statements by members do not guarantee future results.

6. Accounts and Access

Your membership is personal to you. You must provide accurate information, keep your credentials secure, and promptly report unauthorized access. Access may require valid Whop, Discord, and TradingView accounts.

You may not share, transfer, rent, sell, or sublicense your membership, Discord role, TradingView access, login credentials, or any other access rights. One membership may be linked to one personal TradingView account unless Trifecta HQ gives written permission otherwise.

7. Subscriptions, Billing, and Renewal

Monthly and quarterly plans renew automatically at the price and billing interval shown at checkout until canceled. Whop processes payments, renewals, and subscription access under its own platform terms.

You authorize recurring charges until cancellation. You are responsible for maintaining a valid payment method. Taxes and platform charges may be added where applicable. Price changes apply prospectively and will be communicated or displayed as required by law.

8. Cancellation

You may cancel through your Whop account. Cancellation stops future renewals but does not refund the current billing period. Access ordinarily continues until the end of the paid period unless access is terminated for breach, fraud, chargeback, or other misconduct.

9. Refunds

Purchases and renewals are non-refundable except as stated in the Trifecta HQ Return Policy or required by law. Forgetting to cancel, non-use, dissatisfaction, trading losses, a change in personal circumstances, or failure to use available content does not create a right to a refund.

10. Community Conduct

You must behave lawfully and respectfully. Prohibited conduct includes harassment, threats, hate speech, spam, impersonation, fraud, payment abuse, chargeback abuse, unauthorized promotion, disruption, solicitation of members, publication of private community content, and conduct that may harm Trifecta HQ, its members, or its platforms.

11. Intellectual Property and Content Restrictions

All membership materials, market commentary, methods, branding, indicator logic, software, designs, text, videos, audio, charts, assignments, and community materials are owned by Johnny Reyes, doing business as Trifecta HQ, or its licensors.

You receive only a limited, personal, non-exclusive, non-transferable, revocable right to access the materials during an active membership. You may not copy, record, download where downloading is not expressly enabled, redistribute, resell, publish, transmit, scrape, reverse engineer, decompile, modify, create derivative products from, or use the materials to build or support a competing product or service.

Personal notes and private journal screenshots are permitted. Public sharing must not disclose paid materials, settings, source code, proprietary logic, private discussions, or content that enables others to reproduce the service.

12. Member Submissions

You retain ownership of original content you submit, such as questions, chart screenshots, assignments, or feedback. You grant Trifecta HQ a limited license to view, store, reproduce, and use that content as reasonably necessary to provide support, feedback, moderation, security, and administration. Trifecta HQ will not publicly use your name, likeness, testimonial, or private submission for marketing without permission.

13. Third-Party Platforms

The membership relies on third-party platforms, including Whop, Discord, and TradingView. Their terms, technical limits, outages, account decisions, and service changes also apply. Trifecta HQ is not responsible for third-party downtime, suspensions, security incidents, data loss, compatibility changes, or features outside its control.

14. Modifications and Availability

Trifecta HQ may update, replace, suspend, or discontinue any feature, indicator, lecture, channel, schedule, or platform. Reasonable efforts will be made to maintain the overall membership service, but uninterrupted or error-free access is not guaranteed.

15. Suspension and Termination

Trifecta HQ may immediately suspend or terminate access, without refund, for a breach of these Terms, the EULA, community rules, intellectual property restrictions, payment obligations, or applicable law. Access may also end upon subscription expiration, failed payment, refund, reversal, fraud concern, or chargeback.

Sections concerning ownership, restrictions, disclaimers, liability, indemnity, and disputes survive termination.

16. Disclaimer of Warranties

To the maximum extent permitted by law, the membership and all content are provided "as is" and "as available" without warranties of profitability, accuracy, completeness, fitness for a particular purpose, non-infringement, uninterrupted access, or error-free operation. Trifecta HQ does not warrant any trading result, funded-account result, income level, or financial outcome.

17. Limitation of Liability

To the maximum extent permitted by law, Trifecta HQ and its owner, contractors, contributors, and service providers will not be liable for indirect, incidental, special, consequential, exemplary, or punitive damages, or for trading losses, lost profits, lost opportunities, lost data, platform outages, or account actions.

To the maximum extent permitted by law, total liability arising from the membership will not exceed the amount you paid to Trifecta HQ through Whop during the three months immediately before the event giving rise to the claim. This limitation does not apply where liability cannot lawfully be limited.

18. Indemnity

To the extent permitted by law, you agree to defend, indemnify, and hold harmless Trifecta HQ and its owner from claims, losses, liabilities, and reasonable costs arising from your unlawful use, breach of these Terms, infringement of another person's rights, or trading and financial decisions.

19. Governing Law and Disputes

These Terms are governed by the laws of the State of California, without regard to conflict-of-law rules. Before filing a claim, each party agrees to send written notice and make a good-faith effort to resolve the dispute informally for at least 30 days.

Subject to mandatory consumer rights and any court that must legally hear the matter, disputes will be brought in the state or federal courts located in Los Angeles County, California. Nothing in these Terms removes rights that cannot be waived under the law of your country or state of residence.

20. Changes to these Terms

Trifecta HQ may revise these Terms from time to time. The updated version will be posted through Whop or otherwise made available. Material changes apply prospectively as required by law. Continued use after an effective update constitutes acceptance where legally permitted.

21. Entire Agreement and Severability

These Terms, together with the Privacy Policy, Return Policy, EULA, checkout terms, and applicable community rules, form the agreement between you and Trifecta HQ. If any provision is unenforceable, the remaining provisions remain effective. Failure to enforce a provision is not a waiver.
